

## JHS COMPETITION CHEER TEAM CONTRACT

Congrats on being selected as a member of the Jordan High School Competition Cheer Team. This is a great opportunity to learn and grow even more as a cheerleader. Please note that the commitment standards are much higher than the school related teams.

- A. The competition team is optional.
- B. If selected as an alternate you are still part of the team and required to attend **all** competition team meetings, practices, performances, and competitions. You will be expected to be ready to step in when needed.
- C. There are additional fees and members of the competition team are required to pay the fees by the deadline they are due.
- D. You may have a different stunting position that is different than your school team position.
- E. Competition is not school team related.
- F. Competition practices will be held on class days beginning at 6am. There will also be some Saturday practices each month. Additional practices will be held as needed, with advance notice.
- G. Competition team members are required to attend **all** meetings, practices, performances, and competitions. Other obligations must be scheduled around these dates.
- H. If you miss a competition practice more than twice during the year, you will be removed from the competition team.
- I. If you are late to competition practice more than three times during the year, you will be removed from the competition team.
- J. You will be put on probation if your GPA falls below a 2.5.
- K. If you are put on probation, you will be removed from the team until the probation period is over.
- L. You will not be allowed to compete if your GPA falls below a 2.0.
- M. When attending Nationals, you are required to travel with and stay with the team the entire trip. This is not a family vacation.
